

RESOLUTION NO. R-2024-47

A RESOLUTION AUTHORIZING THE MAYOR OR CITY CLERK TO ENTER INTO A CONTRACT WITH BOND CONSULTING ENGINEERS FOR THE PURPOSE OF PRODUCING A CONSTRUCTION ENGINEERING DESIGN TO INCLUDE SURVEY WORK, ADH REVIEWS AND BID MANAGEMENT

WHEREAS, IN MARCH 2024, THE GOVERNING BODY OF THE CITY OF WARD, authorized the Mayor to apply to the Arkansas Natural Resources Commission (ANRC) for \$791,516 in financial assistance; and, would be coupled with a \$500,000 grant from the Arkansas Economic Development Commission (AEDC) to remove the remaining homes off the antiquated sewer vacuum system; and,

WHEREAS ON JULY 17, 2024, THE ANRC approved the amount requested in the form of a 20-year loan at 4% interest per annum; and, in August 2024 the City Council accepted the loan amount via Resolution 2024-39 with reservation as to the stipulations for accepting the loan; and,

WHEREAS the city needs to move forward with the construction design to better determine the estimated cost of the project.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF WARD, ARKANSAS, HEREBY;

SECTION 1 – AUTHORIZATION: The Mayor or City Clerk is hereby authorized to enter into a contract with Bond Consulting Engineers for the services stated on attachment 1 for an estimated cost of \$80,041.28 (attachment 2).

SECTION 2 – FUNDING: Authorizes and appropriates Water/Wastewater Operational and/or Reserve funds to be used to fund this phase of the project and amend respective budgets, as needed


